Barry asked for clarification of check #11274 to Wade Anderson. Payment to Wade Anderson was made for the work done on the pump station. Upon reading of said bills, a motion was made by Butch, seconded by Kevin that the Treasurer pay said bills. Aye Kevin, Fred, Butch, Barry, Mayor Robinson Nay none

Teresa Prather addressed the Village board about the water tower pipe that was placed in her backyard. Mayor Robinson stated that there is a catch basin by the water tower but it has been filled up. Tim McFadden stated that there is a pipe that goes southwest but it's frozen and couldn't be located. Ms. Prather stated that having the pipe in her back yard wouldn't have been so bad if she had been notified prior to it being placed in her back yard. Kevin stated that ice caused the water tower to overflow and was flooding out Mr. Garland's property. Kevin believes there is a tile buried there. There is a manhole in the easement and once we locate the tile, we can hook those up and the water would go to the manhole. Kevin also stated that he has researched the developing of this area and it is stated in the paperwork that the developer was to put in a swell and was supposed to maintain it until he died and then his children would maintain it and that the Village would be looking into this issue this Spring. Mayor Robinson apologized for the Village to Ms. Prather for not contacting her prior to placing the pipe on her property.

Commissioner Voorhees:

- Barry stated that the former Finance Commissioner was authorized to invest the \$300,000.00 to LPL Financial. Since, at that time, investments were not making a lot of money, he went to Keith Souza with LPL Financial. Barry stated that Mr. Souza told him that the account was supposed to be set up at \$200,000.00 being in a pretty secure fund and the remaining \$100,000.00 in a higher risk fund. The Finance Commissioner at that time resigned and direction was never given to Mr. Souza. Mr. Souza requested to come to the next board meeting to explain options within LPL Financial. Barry stated that his opinion was to move the money into CD's but it would be advisable to listen to what Mr. Souza has to say. Barry stated he would have CD quotes at the next meeting also.
- Barry stated that he was meeting with Shelley Darnell, Village Clerk were meeting in the morning to work on the budget for the next fiscal year.

Commissioner Schmink:

 A motion was made by Butch and seconded by Kevin to issue a building permit to the Robert Smith, 118 N Paris, tear off roofing and replace 2 sheets of plywood, felt and reroof, \$2,169.00, Amos Construction, 104-005537.

Commissioner Kirk:

- Kevin stated fortunately there hasn't been more snow and the Village should make it through the rest of the winter with the salt that is currently on hand. Prices on salt went up as the winter season went on and was up as much as fifty percent.
- Carl has cold patched certain pot holes on the streets.
- Kevin stated that he hasn't spoken with engineer yet but would to try to have his budget done. There would be enough money in the Motor Fuel Tax account to do a project but it would take the account down to almost nothing.
- The maintenance building is still without water. This may not be a frozen line, but a blocked line. The street department will start digging to try to rectify the problem.
- The overhead doors on the maintenance building will need to be replaced; the cost should be around \$3,000.00. The heating in the maintenance building will also have to be

addressed. Currently only one furnace is working and it is one of the original furnaces to the building. Painting of the building would also have to be done to prevent rust.

Commissioner Reddy:

- Fred stated that the work at the pump station was done and looks very nice.
- Fred commended Shelley for collecting over \$1,250.00 in outstanding water and sewer bills.
- Fred was working with Tim and Shelley on the next fiscal years' budget.

Kevin stated that the only bid he has received for the generator and outdoor lights for the water department was \$10,000.00. He would be looking into getting more bids and thought they would be able to get a bid lower than the \$10,000.00.

Fred stated that Shelley has sent many emails to Andy at the our engineer office to request an update on the bids for the water tower painting and has not got a response. Mayor Robinson instructed Shelley to call the engineers to get an update.
