The Village Clerk informed the board that there had not been any sealed bids submitted for the sale of the truck. Jim suggested that we set another date and place the truck on the parking lot at the IGA. A motion was made by Kevin, seconded by Aaron to place an ad in The Sidell Reporter for the sale of the truck by sealed bids at the April 19<sup>th</sup>, 2016 meeting and placing the truck on the parking lot with the sale information.

### Commissioner Miller:

- Jim informed the board that the Village Clerk and Deputy Village Clerk were requesting two new computers be added to the fiscal year 2016-2017 budget. Brian Darnell explained the two computers, the local back-up system and how the two computers would be networked together. Jim requested this be added to the agenda at the end of April to be ordered at the beginning of the next fiscal year.
- A motion was made by Jim, seconded by Fred to approve the purchase of a new drop box for the Village Clerk's office for \$174.00.

### Commissioner Richardson:

- Aaron informed the board that he had one building permit but he has been unable to reach the property owner for an inspection.
- Janice Shepherd of 405-407 Douglas was requesting to add a two car garage to her property. Aaron explained that she owned two lots, 405 and 407 Douglas but the lots were combined onto one tax bill. The house sits on 407 Douglas and they currently have a three car garage on 405 Douglas. Kevin stated that if the tax bill shows is combined, that would make the properties one parcel and the property owner would have to have proof of the lots being separated. However, she would be able to get a yard barn if the lot was big enough to maintain the open space requirements set forth within the Ordinances.
- Seth Smoot would be completing the ceiling within the building at the Splash Park this week. Once that is complete, the doors will be installed. Aaron stated he was looking into rubberized flooring for the Splash Pad and waiting for an email from a company out of Ohio. Travis Pearman would be installing the sewer line as soon as the weather permits. Mayor Schmink asked if the park would be ready by Memorial Day and Aaron stated as soon as we have two nice weeks of weather, it could be completed.
- The tree at 204 Buckingham has been removed.

### Commissioner Kirk:

- The Street budget was submitted to the Clerk today. Kevin stated that the current street budget is over on the street maintenance line item due to the unforeseen need to replace the bridge at Jones Grove Cemetary.
- There are a lot of potholes within the Village and the Street Department would be addressing those as soon as weather permits. Kevin also stated that there are some alley's that are in very rough shape and may be turned back to gravel.
- The tree removal and replacement line item within the next fiscal year budget was also increased to replace some of the trees that have been taken down, specifically the trees at Mapleleaf Drive.
- Aaron asked about the storm sewer on Short Street. Kevin stated that he noticed there was a problem there also and has added funds to the budget to address and fix this problem.

• Kevin asked Matt Johnson if the field on South Paris Street would be grated and ready for the farmer to get into the field by April 1<sup>st</sup>. Matt stated he would contact Cross Construction and make sure it was ready by April 1<sup>st</sup>.

# Commissioner Reddy:

- Fred informed the board that the wastewater treatment gear was not repaired yet and wouldn't arrive for approximately three more weeks.
- A motion was made by Fred, seconded by Kevin to approve the agreement for professional services from Fehr Graham for the wastewater facility planning for \$5,000.
