- The Street Department is working on the Splash Park this week. Once that is complete, they will begin on cold patching and repairing the roads.
- The road between the Catlin Bank and Casey's where the water is pooling needs to be addressed and fixed this year. Once that is done, Kevin would like to add Short St. to be resurfaced in the next MFT project.
- There are ten applicants for the two summer positions for the street department. Carl will interview all ten and make his decision on which two to hire.


Commissioner Reddy:

- Tim informed the board that the gearbox was back on the wastewater plant.
- Cross Construction is working on the yards at the south end of town where the new water main was installed. There should be a final walk-thru with the engineers, the Village and a representative from Cross Construction.
- The Catlin Fire Department was practicing in Westwood Circle last week and caused damage to the plumbing of one of the homes on Westwood Circle. Tim explained that when they open the fire hydrants it causes a severe pressure drop and can damage pipes and plumbing. Tim also stated that an additional 26,000 gallons of water was used that day and that water has to be paid by the Village and Village residents. Kevin suggested the Village schedule a meeting with the Fire Department to determine what happened and what will be allowed in the future.


A motion was made by Aaron, seconded by Kevin to adjourn the meeting by vote.
