Crystal Carter addressed the board about her concerns for the safety of her customers at High On The Hog due to the condition of the sidewalks. Mayor Robinson asked Barry if he had heard or seen this on a previous agenda under Mayor Woodard. Crystal explained that the sidewalks were never discussed at a meeting but rather in person in front of the business. Kevin stated that after seeing this topic on the current agenda, he drove down to take a look at the sidewalks. Kevin agreed that the sidewalks were about fifty to sixty years old and in need of repair. He did some quick figures and for 1200 square feet of concrete with the Village employees removing and doing the backfill and contracting the remaining out would cost the Village around \$4200-\$5200. Kevin stated that unfortunately, this was not in the budget for this year but it could be put in the budget for next year and we will work on getting bids. Crystal stated that she was very pleased with the board decision. Mayor Robinson thanked Crystal for coming to the meeting.

- Tree stumps between the funeral home and the photographer will be removed the next couple of weeks. Any damage done to the asphalt will be saw cut and cold patched this year. Kevin stated he would like to see this alley be resurfaced next year.
- Kevin asked Carl if we need to hang on to the older mower. Carl stated it would be best to hang on to it for now.

Commissioner Reddy:

- Fred stated that Wade Anderson has the materials ordered for the two approved bids.
- The tree at the pump station has been trimmed.
- Fred stated he would get with John Puzey to discuss the water being used by the Township and to come to resolution on how that should be billed.
