### Commissioner Kirk:

- Kevin stated that we were hit with snow this past weekend and the Village employees did a great job, much better than the county. Mayor Robinson stated that he had spoken with the County and was informed that they were restricted to only plowing twelve hours due to time and equipment restraints. Kevin stated that our guys can plow until it's done with all necessary breaks. Mayor Robinson directed the Village Clerk to draft a letter to the county board addressing the safety and lack of plowing on the Catlin-Homer Road.
- The streets department helped the water department the past week with a couple of water main breaks.
- The second streets employee has received his CDL.

## Commissioner Reddy:

- Fred stated that the water department had two water main breaks.
- The EPA sent a letter requesting a plan if part of the pump station breaks again. Fred stated that he wants us to get the part and have it on hand in case there is a problem in the future and this should be sufficient for the EPA.

The Village Clerk informed the board that the Deputy Village Clerk's computer is not working. The Deputy Village Clerk called and got quotes from three local computer repair companies in Danville, Computer Clinic, CTS and Fortress PC. Chief Cook stated that he had Fortress PC fix the laptop in the squad car and that Fortress had been to the office to check on the computers when they thought they were hit by lightning. A motion was made by Barry, seconded by Fred to have Fortress PC to fix the Deputy Village Clerk's computer.
