Kevin stated that he wanted to bring attention to check #17456, Ameren. Kevin stated that over one-third of this bill was for the maintenance building. The maintenance building has two elevated furnaces. In order to keep the sand and salt warm the building has to be kept at a certain temperature. Kevin suggested the board start thinking about adding a new furnace next year and stated he would have some plans before the next budget is passed. Upon reading of said bills, a motion was made by Kevin, seconded by Butch that the Treasurer pay said bills.

Commissioner Voorhees:

- Mayor Robinson stated that Barry was unable to attend the meeting but had checked around on the best interest rate for the two CD's that were currently at the First National Bank of Georgetown. Mayor Robinson read the following:
 - 1. First National Bank of Georgetown has offered a 1 year interest rate of 0.65% on both CD. This is the best rate offered on a 1 year CD.
 - 2. Catlin Bank has offered a 1 year CD rate of 0.40% and a 2 year CD rate of 0.60%.
 - 3. United Community Bank (Oakwood) has offered a 1 year CD rate of 0.40% and a 2 year CD rate of 0.70%.
 - 4. Central Illinois Bank (Danville) has offered a 1 year CD rate of 0.40% and a 2 year CD rate also at 0.40%.
 - 5. Illinois National Bank (Fairmount) has offered a Rising Rate CD. 6 months @ 0.15%, 12 months @0.25%, 18 months @0.35%, and 24 months @ 1.10%. We would be able to withdraw at the 6 month periods.

A motion was made by Kevin and seconded by Butch on the recommendation of the Commissioner of Finance to reinvest CD's, CD 12609 and CD 12608 with the First National Bank of Georgetown.

Commissioner Schmink:

A motion was made by Butch and seconded by Kevin to issue a building permit to the Vicki Young, 109 Delmar Dr, replace 8'x10' yard barn with a 16'x24' yard barn, \$4,000.00, 5 Star Buildings and to issue a building permit to Charles Nesbitt, 112 Larkspur Dr, 8'x12' pre-built yard barn, \$2,100.00, Yoder's.

Commissioner Kirk:

- Kevin stated that Christmas decorations were still up due to the bitter cold and weather.
- The street department was currently out clearing the roads and that the street budget would be out of whack a bit due to the extreme weather we have had this winter.
- Kevin and Carl would be getting together to create a proposal for the board for work that needs to be done on the maintenance building.
- Kevin also spoke with the engineer about doing a street project with our Motor Fuel Tax dollars.
- The Safe Routes to School Grant has been submitted with the engineering being included which forced the existing crosswalk upgrade to be removed from the plans.

Commissioner Reddy:

- Mayor Robinson stated that Commissioner Reddy was unable to attend the meeting.
- Kevin stated that the water department has had two water main breaks and two sewer line plugs since the last meeting and that the water and street department worked together to fix both of these.
- Mayor Robinson stated that the specs for the water park were received. Kevin stated that a representative from Water Odyssey was coming on Tuesday, February 11th and if possible, he was going to meet with them to get answers on additional questions he has. Kevin questioned the pad, if it was a footed or floating pad. These are questions we need to have answered to get pricing. Kevin also stated that he has reached out to members that put in the water park at Garfield Park.
