Mayor Robinson read the Thank You letter received by the Village from the Ladies of Catlin regarding the Strawberry Festival.

Mayor Robinson informed the board that an invoice was sent to the Catlin Fire District for the clean-up at the Bunge Elevator the previous night. The Catlin Fire District is required to submit all invoices together per State law. The Village sent an invoice for \$569.20. Carl stated that maybe the Village should send them a letter stating they are no longer allowed to pump onto the streets. Kevin requested that Shelley obtain a name and number for the Bunge Elevator and he and Carl would contact them. Kevin also stated since the substance was bad beans and stagnant water, these are organic materials and shouldn't cause harm to anyone or thing.

Mayor Robinson requested that the Street Department place a new flag and rope at the Catlin Park.

Commissioner Voorhees:

Shelley stated that she was directed by Barry to look into online payments for the water and sewer bills. LOCIS, the water and sewer program that the Village uses, recommends Payment Service Network. The initial cost is \$199.00, then \$12.95 per month and a yearly \$89.00 for a security compliance fee. Kevin stated that a lot of companies have gone to electronic payments and we could try it for a year. There was discussion about the property outside of the Village limits, within the Township. The property needs to be mowed. A letter from the Township to the Village regarding the property was to be sent and should be received this week.

Commissioner Kirk:

• Last week the new overhead door was installed on the maintenance building. The steel header is bowed and a piece is going to be added.

- Street sweeping began last week, along with a lot of patching. Carl is not happy with the current patch that the Village received. Stated that it wasn't very sticky and looks like it sat all winter. Kevin stated that the Village could go purchase and pick up better patch in Champaign-Urbana but it is about double the cost.
- Josh Keith started working on the alley between Wabash & Seminary. The alley behind the new apartment buildings. Kevin asked the other board members and Mayor to be please look at the work that has been done and let him know what they think.
- The part-timers are working out very well.

Mayor Robinson asked if anyone had seen chickens in town. He was informed that there were chickens behind the minister's house. There is an ordinance that forbids farm animals. Kevin stated that many municipalities are allowing a certain number of chickens per house. Mayor Robinson stated that he did not think this was a good idea.

Commissioner Reddy:

• The property at 214 N Sandusky has hired a contractor for their sewer hookup and they were informed that they would have to fill their septic system.

Kevin inquired about the painting of the water tower. Shelley stated that she has not been notified of any time that they would begin but she finally received the CCR report from the engineers.

Butch stated that the clean-up day signs were up.
