### Commissioner Kirk:

- The Street Department has been cleaning up the streets between the rains. Four alleys were done for a cost of \$900.00. The little amount of rock that has to be added is coming from the current inventory. Mayor Robinson stated that working on the alley's is a great idea and it should continue.
- The berm at the grade school is still on hold until the rain stops.
- Later in the summer the work on the sidewalks will start. Some sidewalks have to be replaced due to broken water mains and other due to old age.
- The overhead door at the maintenance shop was replaced. Kevin is talking to companies about the gutter and painting should begin at the middle to end of the month. The shop would be water blasted, primed and then painted.
- Kevin asked Shelley about the sidewalk grant. Shelley stated that it would be late fall before the grants were awarded.

## Commissioner Reddy:

- The pump station is about ninety percent complete and looks very good.
- The water tower painting will begin on August 1<sup>st</sup>, 2014.
- Fred spoke with the engineers about the Merrill Street project and the engineers stated that they believe strongly that our grant looks good and we have a very good chance of receiving this grant.

Kevin stated that the sewer line at Center Street has been worked on and the worst part of the sewer line has been cleaned out and corrected.
