Kevin asked for clarification on Homefield Energy. Shelley stated that this was the new supplier for the Village and is taking the place of Constellation Energy. Upon reading of said bills, a motion was made by Butch, seconded by Fred that the Treasurer pay said bills. Aye Kevin, Fred, Butch, Jim, Mayor Robinson Nay none

Delores Dodson addressed the board about the repairs done on the sewer line to her house. Tim stated that everything had been replaced that was bad on the camera when it was scoped. Delores stated that her basement had to be cleaned up. She needs to have the paneling and carpet torn out and replaced. She stated that her insurance was covering the work but there was a \$500.00 deductible that she is requesting Village pay. Mayor Robinson asked for clarification, if the actual sewer line backed up in the basement. Delores stated that it happened twice. There was a big puddle in the middle of the floor with toilet paper all over the place and the carpet was all wet. Kevin asked if there was a toilet in the basement. Delores stated that there was not, just her washer and dryer. Kevin asked if it was the actual sewer or the storm water that had backed up. Tim stated that both the sewer and the storm water are down in the basement. Bill Willett stated that the storm and sewer lines are not connected. Delores stated that she had Newton's come out and they had a meter that read mold and mildew and the meter went way over when they were reading the basement. Jim made a motion to split the \$500.00 deductible and have the Village pay \$250.00. Bill stated that he did not think this was fair. Mayor Robinson asked if anyone would make a motion to pay the full deductible. Fred made a motion, seconded by Jim to pay \$500.00 towards Delores Dodson's insurance deductible for the repairs in the basement due to water damage.

A motion was made by Jim, seconded by Fred to approve Ordinance # 725: Ordinance Amending the Municipal Code with Respect to Police Department Hiring Standards. Aye Jim, Fred, Kevin, Butch, Mayor Robinson Nay none

Commissioner Miller:

• Jim stated that the air conditioner in the large board room is now working but there is some work that needs to be done soon on the units. Jim has spoken with Ron Smoot from the Township board and they believe that with the bid from Blackies to replace both the evaporator coil inside and outside unit, change the refrigerant from R22 to the newer more environmentally friendly R410A at \$3,885.00 would be accepted by both boards. Kevin stated that this would be a much more efficient unit. Mayor Robinson stated that the units were original to the building that was built in 1978. Jim stated that he would be attending the next Township Board meeting and would report back to the Village at the next meeting.

Commissioner Schmink:

- A motion was made by Butch, seconded by Kevin to issue a building permit to Phyllis Nightlinger, 301 W Vermilion, tear out and replace front porch, \$1,400.00, Lomax Aye Kevin, Fred, Butch, Jim, Mayor Robinson Nay none
- A motion was made by Butch, seconded by Jim to issue a building permit to Dustin Heckerson, 823 W Vermilion, fence, new roof and new windows, \$24,000.00, S&K, 104.015412.

- A motion was made by Butch, seconded by Fred to issue a building permit to Barb Jessup, 104 Meadowlane, tear off and re-shingle roof, \$5,900.00, Frank Atwood, 104.010015.

- A motion was made by Butch, seconded by Jim to issue a building permit to Hardie Marble, 210 N Sandusky, build new garage/shed 24' x 20', \$5,000.00, Self. Aye Kevin, Fred, Butch, Jim, Mayor Robinson Nay none
- Butch stated that the new LED lights at the park are being finished today. Butch asked if
 the lights east and west of the flag pole were the Villages'. Carl stated that they were.
 Butch stated that he would look into having LED lights placed on these as well. Mayor
 Robinson stated that the new flag at the park looked very nice and thanked Butch and the
 Village workers for completing this task.

Commissioner Kirk:

- The three alleys on the south end of town have not been completed at this time. The private contractor that was hired to complete these has been busy but this is expected to be completed soon.
- Street department has continued to street sweep and painting the roads.
- The grade school berm is done and seeded.
- All Village employees have been working together to complete the sewer project on
 Center Street and replace the water line at Jessup's on Faust Drive. Tim stated that
 Jessup's still have poor water pressure but there is a galvanized valve on their house.
 Mayor Robinson stated that it is on their house and they would need to call a plumber.
 The Village has done all it can do to help and the remaining issues are within their house.
- The maintenance building has been painted and the gutters will be place on tomorrow. The weeks around the building have been sprayed and there will be nothing but rock around the building.
- The ability to buy salt this year with the Township has been taken away by the state. Kevin stated that he is not sure where we are going to be able to purchase it. Kevin is currently looking for an independent supplier. Kevin stated that the Village could go back to what it did fifteen years ago and just spread sand but there are a lot of problems with this method. It is very difficult to clean up in the Spring/Summer, it clogs up the storm drains and it does nothing to melt the ice only helps with traction. It is extremely important to make sure that Vermilion Street and the road next to the High School have

been salted. Mayor Robinson stated that Chad Hays should be contacted to help with this issue. Kevin stated he would be in contact with him.

Commissioner Reddy:

- The water tower painting has run into a few problems. Tim stated that the valve did shut off and that the tower has been drained and the valve does not need to be replaced. Fred stated that the cables may need to be replaced. Tim stated that the engineers should be at the board meeting to explain what upgrades need to take place. Kevin stated that the engineers came to the board meeting last year and stated that it was in the Village's best interest to have the tower painted for \$75,000 and to keep the water tower.
- The property at 121 Carrigan was having septic problems and had asked if they could be placed on the Village's sewer. The property is 200 feet below and would have to have a lift station installed to be added to the current sewer system. Kevin stated that twenty years ago it was the only property that was deemed by the EPA, financially unacceptable to be placed on the Village's sewer system. Since the house was deemed unable to be included in the EPA loan, it was not on the repayment program and have never paid into the sewer surcharge. Fred requested that this information be added to their property file so any future board would know what has happened.

Tim stated that he had never seen water in the basement of Delores Dodson and he has pictures of the sewer system that Shelley would print and have added to their property file. Kevin stated that after years of working in the housing industry, he has seen companies with meters come in and if they would open it up and let it breathe, it wouldn't be detected.
