• Jim Miller informed the board that three bids had been obtained for the replacement of the furnace and air conditioning unit in the Village/Township Hall. The bids from Blackies (\$5,898,) Wrights (\$5,000,) and Kuchefski (\$7,360.) Butch asked for clarification on the different aspects between Blackies and Wrights. Jim stated that Blackie's has a ten year compressor warranty, ten year parts warranty and a one year labor warranty. Wright's has a one year parts and labor warranty because that is all they are allowed to give. Kevin stated that to include the furnace was only an additional \$1200 and the furnace is original to the building that was built in 1978. Jim suggested that we approve and accept the bid from Wrights and pass on to the Township for approval. Kevin stated that if the board is in agreement, allow the Township board to choose and the Village board would go along with their recommendation. A motion was made by Jim, seconded by Kevin to approve of the recommendation of the Township Board to replace the furnace and air conditioning unit at the Village/Township building.
