Kevin explained that since the Village does the decorations and the job is not hired out, the workers have to do it when the weather is safe for them to be up in the air.

Mayor Schmink reminded those present that the annual lighting of the community Christmas tree would take place at the Community Building on Sunday, November 29<sup>th</sup> at 5 PM.

## Commissioner Reddy:

• Fred informed the board that there was a backed up sewer line on Byerly today but has been cleared. A resident on Byerly called and stated that he had sewage backed up in his basement. Tim stated he would go and look at it tomorrow. Kevin stated that drains should not be hooked up to the Village sewer lines. Kevin also stated that older homes that had basement drains that were hooked up to the sewer should know that this is illegal and any damage caused by them being hooked up illegally is homeowners liability.

Matt Johnson requested that the wastewater plant facilities plan agreement between the Village and Fehr-Graham be placed on the agenda for the next meeting. Kevin asked when the last evaluation of the wastewater plant took place. Matt stated that Fehr-Graham had completed one in 2012 but the one purposed to be done under this agreement would be more thorough.
