Kevin asked for clarification on General check #184051 to Keep Vermilion County Beautiful. Shelley stated this payment was for the yearly membership. Upon reading of said bills, a motion was made by Jim, seconded by Kevin that the Treasurer pay said bills as presented. Aye Fred, Kevin, Jim, Aaron, Mayor Schmink Nay none

Mayor Schmink called for public expression. After hearing none, Wayne Tennyson addressed the board regarding the Westwood Circle subdivision road. Wayne asked for a timeframe of

when the Village would be putting the lift on the road. Kevin stated that the Village engineers created a multi-year plan for Motor Fuel Tax (MFT) projects. Westwood Circle is on the schedule for 2022. Kevin explained that this plan was not set in stone and things could change. The engineers and the Street Department meet each year and access which road(s) need to be addressed that year. Kevin also stated that after inspecting Westwood Circle, there was only some breakup along the catch basins which would be addressed this year. Kevin stated that it is in the best interest of the Village to maintain the road at Westwood Circle. Mayor Schmink asked if a load limit should be put on Westwood Circle. Kevin stated he didn't think there were large trucks using the road except for when a home was being built. Jim stated that the pavement wasn't pumping and there was not much wrong with the road. Wayne stated that those on Westwood Circle pay a high tax which Kevin responded that all residents pay the same percentage.

A motion was made by Jim, seconded by Kevin to pass the Resolution for Maintenance of Streets and Highways by Municipality Under the Illinois Highway Code. Aye Fred, Kevin, Jim, Aaron, Mayor Schmink Nay none

Matt Johnson stated that the substantial walk-thru had been completed today. A list of corrections was given to Cross Construction to complete.

A motion was made by Fred, seconded by Jim to approve the pay request from Cross Construction of \$130,706.59 for work done on the water main project.

Kevin asked if the patch work on Farrar Street would be done and would it come out of the Motor Fuel Tax Fund. Matt stated that inquiries to DCEO to cover the edge to edge repair would be made. Fred stated that after the walk-thru he thought the job was done well and within a timely fashion.

Dave Harrold explained to the board that the Catlin Police Department was requesting approval to purchase new digital radios. Dave explained that the entire system was upgrading to digital and if Catlin did not purchase the digital radios, the officers would be unable to communicate with other agencies or 911 dispatch. Dave also explained that the last two times that Catlin needed to upgrade, grants or donations were made to cover the cost. Due to the cut of any grants for part-time police departments, there are not any grants available to help offset this cost. Dave explained that himself, Tad Beddow, the Chief of Police and Jerry all kept radios at home also. He stated that some of the newer officers may need help with certain situations and this allows them to know when to respond. The current bid of \$12,587.93 from Supreme Radio Communications, Inc. is good for thirty days. Kevin stated that we would need to look at the budget and see where these funds could be drawn from. A motion was made by Kevin, seconded

Commissioner Miller:

- Jim thanked Mayor Schmink and Kathy Swearingen for their donation of their time on repainting the community room.
- Jim explained to the board that himself, Mayor Schmink, Kathy and Tim all took time to remove tape and patch holes in the community room. Jim stated that there are rules that are handed out when people rent the room but they are not being followed. Mayor Schmink explained the first night the community room was rented, there were decorations hanging on the walls after the rules explicitly state "Table decorations only." A contract was written up by Shelley for those renting the room. The contract has each of the rules and a space where the renter would initial, indicating they have read and understand the rule. At the bottom of the contract, there is a place for the renter and the Clerk to sign and it states that if the rules are not followed, the deposit on the room for the matching amount of the rental cost would be forfeited. Mayor Schmink explained that he had spoken with Chief Beddow and the police would be checking on the community room over the weekends. Aaron stated he did not like the police walking in on a party. Kevin stated that the community room income and expenses are shared with the Township. Kevin stated that the Village needs to contact the Township and review the Village and Township building once a month. Jim stated he would talk to Ron Smoot about the deposit requirements and rental contract. A motion was made by Jim, seconded by Fred to approve requiring a deposit for the rental of the community room for a matching amount of the rental cost contingent upon the approval of the Township board.
