The board requested Terry Dolan present them with the engineering report and contractors contract for the property at 101-103 S. Sandusky. Terry stated he did not bring any paperwork with him and he must have misunderstood. Terry stated he thought he only had to come back and report what was to be done. Terry stated he has hired B&B Construction to re-side both buildings. Mayor Schmink asked why Terry had obtained an application for a demolition permit from the Clerk's office months ago and then decided the buildings were safe? Terry stated that tearing them down was a personal decision but after receiving the insurance settlement, he wanted to fix them up. Mayor Schmink instructed Terry to provide the engineering report stating that the buildings were sound and the contractors contact to the Village Clerk by the end of the week. Shelley also stated that a building permit would need to be obtained prior to re-siding the buildings.

Commissioner Miller:

• Jim informed the board that a Public Hearing regarding the closure of the CDAP Grant would take place before the next Village Council meeting on October 4, 2016 at 7 PM.

Commissioner Schmit:

• In Wanda's absence, Kevin presented the building permit application for Megan Gooch. A motion was made by Kevin, seconded by Jim to approve the building permit for Megan Gooch, 102 Burris, removal of current concrete pad and replace with a 12'x26' concrete pad.

Commissioner Kirk:

- Kevin stated that the bid that was presented to Tim for the asphalt repair at 101 S. Paris was incorrect. The business owner informed Tim of the error. Due to that bid being higher than expected, Kevin stated he has called two additional companies for bids. He is awaiting those bids.
- One bid for the asphalt and relining of the parking lot by the IGA has been received. Two additional bids have been requested. Kevin is awaiting those bids.
- The material for the storm sewer repair on Short St. has been received and that project will begin shortly.
- Carl informed the board that the dirt pile at the maintenance shop is almost gone and should be completed by the following day.

Commissioner Reddy:

- Fred stated that one pump was still down at the lift station, they are awaiting a replacement seal.
- Fred instructed Tim to get a couple of buckets of tar to re-tar the roof at the wastewater plant. Fred asked Matt Johnson what a reasonable cost to repair that roof would be. Matt stated that without looking at it, he would imagine that the price could vary from \$10,000 all the way up to \$30,000.00 but it is hard to say without getting up there and looking.
- Matt stated that he would be requesting additional information regarding the wastewater company from Shelley and Tim this week. Fred asked if Matt planned on attending the Public Hearing to close out the CDAP Grant. Matt stated he would be there if it were requested but it was not necessary.
