Jim asked for clarification on the General Check #184410 to American Legal Publishing. Shelley stated the payment was the update on the Ordinances. Kevin asked for clarification on General Check #184415 to Norfolk Southern. Shelley stated this payment was the annual rental of the property where the semi-trucks can park. Dave Jones addressed the board regarding the Catlin Fire Protection District. Dave informed the board that as of October 1, 2016, Arrow Ambulance will be in Catlin 24 hours a day, seven days a week at no charge to the Village. The ambulance will take a patient to any hospital they wish to be transported to unless certain apply such as severity of the patients' condition or if a certain hospital is too busy to accept another patient.

Dave Jones asked for the board to approve the CFPD purchasing and installing the training facility he had presented to the board previously. Kevin asked what days would there be training. Dave stated their training was done on Wednesdays and once a month on a Saturday. The board stated they supported the idea of the training facility but requested that the CFPD reach out to Skip Wear to get his blessing. While the facility is in a commercial district within the Village, the board wanted to extend courtesy to the neighbors of the facility.

Kevin addressed the changes that could be made to Ordinance 92. Kevin stated that some residents cause issues with the storm sewers by blowing their grass clippings and leaves into the street. Kevin stated that countless hours are spent cleaning out the storm sewers. Kevin stated he would like to sit down with the Village Clerk and draw up a proposal to be presented for approval of the board and to be sent to the Village Attorney to be written up into Ordinance form.

Mayor Schmink stated that the Catlin American Legion was requesting donations to help purchase a PTSD service dog. A motion was made by Jim, seconded by Kevin to approve a donation to the Catlin American Legion for \$200.00 to be paid out of the Health & Safety budget.
