Kevin asked for clarification on the General Check #184473 to Shirley's Custom Lights. Shelley stated this was for the Holiday Light Parade. Sponsorship payments were received by the Village and then one check was cut to the vendor. Shelley further explained that the same GL was used and would credit/debit to balance. Fred asked for clarification on General Check

#184490 to Taser International. Tad informed the board that this was for replacement cartridges for the Tasers. Kevin asked for clarification on General Check #184507. Shelley stated this was for work that was done on the Township and Village Hall. This expense will be included on the Township invoice next month with a 60/40 split, with the exception of \$50.00 that was charged to have the new drop box installed within the Village Clerk's office. Dave Harrold addressed the board regarding the street conditions during winter, specifically this morning. Dave stated that residents have a hard time getting around the Village during winter and this morning, cars were backed up along Westwood Drive on the hill. Carl Chambliss drove by and was kind enough to place some salt down on the hill. Dave stated that he had asked the Street Department to salt the streets but was told that there was an appointment in Danville and the streets would have to wait until the other street department employee came in. Dave stated that there should be a contingency plan for times like this. Kevin stated that the ball was dropped this morning but it has been addressed and will not happen again. Mayor Schmink stated that he understood where Dave was coming from and that Kevin has addressed within the street department.

Joyce Miles stated she has concerns regarding the downtown area of Catlin. Joyce stated that the Village mourns the loss of the IGA and we all hope that a store re-opens but the buildings at 101-103 S. Sandusky is a two-fold problem. Joyce stated that not only is winter here and due to the building being open in areas, it is a great harbor for rodents. Joyce stated that Catlin has a wonderful school district but those buildings do not create any curb appeal and curb appeal is needed when people come to town to look to move to Catlin. Joyce stated that she would like to see something done with those buildings. Mayor Schmink stated that it is also a concern of the Village and it is being addressed.

Katie Griffin asked if any progression had been made regarding the electricity for the semi-truck drivers at the semi-truck lot. Kevin stated that after some research, it was determined that the cost would be so high that it would not be beneficial for the Village, nor the semi-truck drivers. Katie stated that if her husband had to drive back and forth from State Line to their home in Catlin, it would cost them an additional \$147.00 per week. Mayor Schmink stated that the Village Ordinance is in place and would not be changed. Kevin stated that business owners have cost of doing business and this Ordinance has been in place for twenty years. David Biggerstaff suggested that Katie checks into the Crop Production Services property since it is no longer being used.
