- Wanda informed the board that she had received additional information regarding the property at 406 Allison from the Village attorney and from Vermilion County Title. The property is on the trustee sale for August 29th. The Village has the right to take the property off the sale by notifying the trustee and paying the fee, the fee last year was \$639.00. Kevin asked if the Village had received any estimates for the tear down and cleanup of the house on the property. Shelley stated she had requested three estimates and received one for \$9,000.00. A motion was made by Wanda, seconded by Kevin to approve the purchase of 406 Allison from the trustee.
