Doug Toole of the Vermilion County Health Department and Brenda Adams from Keep Vermilion County Beautiful (KVCB) addressed the board regarding their renewal with KVCB. Brenda stated that if the board was to renew their 2018 membership now, they would get it at the 2017 price. Brenda also went on and stated that the Catlin Legion just received one of their beautification grants. Membership also gives the Village a seat on their board. Kevin asked Doug about recycling within the County. Doug explained the obstacles that were faced when the County did have recycling drop offs. Doug said there's an electronics clean up taking place at Danville Area Community College for all county residents on October 28th from 9 AM until 11 AM.

A motion was made by Kevin, seconded by Fred to approve the Village's membership with Keep Vermilion County Beautiful with a membership fee of \$150.00.

Commissioner Cummings:

- A motion was made by Jerry, seconded by Kevin to approve the following building permits:

Commissioner Schmit:

- Wanda informed the board that the deed for 406 Allison has not been received yet. However, there is interest from a party to buy the property as is. Wanda stated that once the deed was received, the Village would have to advertise the property and the sale would be contingent on the buildings that are currently on the property being torn down or restored within thirty days. Kevin stated that by law the Village would have to treat it as excess property and be put out for bid.
- Wanda also informed the board that the Second Annual Holiday Light Parade would take place on December 3 at 6 PM.

Commissioner Kirk:

- Kevin informed the board that the railroad would be doing some repairs to the Paris Street railroad crossing in 2019.
- The storm sewer has been fixed in the alley between Webster and Douglas and the work being done on storm sewer between Webster and Center St. should be completed next week
- Carl informed the board that the airbag was leaking in the Street Departments' truck. That has been fixed and the one-ton truck was back in the shop having the brakes worked on.

Commissioner Reddy:

- Fred informed the board that the south end of town from Paris to S. Sandusky has all had the new electronic read meters installed.
- An eight-inch pipe at the wastewater plant will need to be replaced. The Village workers will do the digging and that will save the Village some of the cost.

Mayor Schmink stated that he has spoken with a representative from the Illinois Commerce Commission. A preliminary hearing will take place on November 6, hearings will begin on November 7, 8, 9. There will be briefing rounds that begin at the end of November. Mayor Schmink stated that he would be testifying at one of these rounds. Shelley stated that additional information would be available at the next meeting. Mayor strongly encouraged the residents of Catlin to keep calling, emailing, and mailing the Illinois Commerce Commission.

Kevin asked Wanda if she had received a bid from Simmons Tree Service for the trimming of the trees. Wanda stated she had not but that she would follow up with him.
