Kevin brought attention to General Fund check #185016 to Newell Construction and Water Fund check #12287 to Midwest Asphalt. Kevin stated the Newell Construction was for the guardrail replacement that would be fully reimbursed to the Village by the Insurance company of the motorist and the Midwest Asphalt was for the assistance given to drill through the asphalt on the corner of Center and Sandusky where the water main had broken. David Biggerstaff addressed the board during public expression. Dave said that the property at 109 or 111 E. Harrison was an empty house and could become another "406 Allison" where the Village would have to step in and take care of the problem. He requested that Village look into the property as the roof was already caving in. The Village Board assured David that they would investigate the property.

Amanda Reed addressed the board on behalf of the Salt Fork North Elementary OPT. Their third annual FunWalk fundraiser was coming up and Amanda requested the board consider being a sponsor. Amanda stated that all funds that were raised went directly back to the classrooms and allowed the OPT to get away from the door to door fundraising sales that had been done in the past. Kevin stated that Smoot Construction has been a sponsor and in the past and thinks this is a great opportunity for the Village to give back. Commissioner Kirk:

- With the recent weather, the Street Department has been out on the streets two or three times, salting and cleaning up slush. The budget line for salt and sand is still in good shape.
- There are four street cutouts that will need to be replaced when the weather breaks.
- Kevin received a message from the Village engineers, Fehr Graham regarding the Webster Street sidewalk replacement. Progress has been made but there is some environmental work that must be done, including a PESA survey that will push back our schedule about a month.
- Dave Biggerstaff asked for Kevin to investigate the pothole/manhole at the corner of Sandusky and Fleming. Kevin stated the Street Department would look into it.

• Fred stated that Devin Gay has started and Tim stated he was doing a very good job.
