Kevin asked if the General Check to Owen's Auto Glass was for the windshield replacement. Carl confirmed that it was for the replacement. Kevin asked for clarification on General Check to YR Tires and Blackies Heating and Cooling. The Clerk stated the YR Tires was for new tires for the Street Department truck and Blackies was for regular maintenance. Upon reading of said bills, a motion was made by Kevin, seconded by Fred that the Treasurer pay said bills as presented.

Angie Anderson addressed the board during public comments. She wanted an explanation as to why she paid twice the regular rate for water. Mayor Schmink stated this was due to Ordinance 50.06. Angie also asked about the lack of water pressure when the pump station kicks on. Kevin stated that previous owners of the two properties that are before the pump station were aware of the situation and were told to elevate the issue, they would need to install a pressure tank. Kevin stated that it was a privilege for those outside of the Village limits to be able to access the Village's water lines.

David Biggerstaff asked if the Village had been notified of a final outcome regarding the Illinois Commerce Commission's decision to Aqua's request to raise the water rate for the Village by forty-seven percent. Mayor Schmink stated that the Clerk has reached out to the ICC and Aqua and had received conflicting determinations and until the Board is certain of which answer is correct, the board did not want to comment. Mayor Schmink stated he wanted to make sure the information was correct before informing the residents of Catlin.

Commissioner Cummings:

- Jerry asked the Village Clerk if she had received a response from the Township regarding
 the carpet cleaning estimate received. The Clerk stated that the Township had approved
 the bid from Newton's and she was working with Newton's to determine when the best
 day to get the carpets cleaned.
- Jerry asked for the board to submit their budgets to the Village Clerk prior to the next meeting.

Commissioner Schmit:

• In Commissioner Schmits' absence, Mayor Schmink opened the one bid for the property at 406 Allison from Don and Joe Crist for \$1,275.00. A motion was made by Kevin, seconded by Fred to reject the bid from Don and Joe Crist due to it not meeting the standards set forth by 65 ILCS 5/11-76.4.1, the Village may not accept an offer less than \$6,400 (Eighty percent of the appraised value of the property,) which was included in the Notice of Sale of Surplus Real Estate.

Commissioner Kirk:

- Kevin stated the street department budget was in good shape with the exception of engineering where money was spent from the General Fund for the past Motor Fuel Tax project instead of out of the Motor Fuel Tax Fund, but was a wash on the budget.
- Cold patching will begin as soon as the weather breaks.
- Kevin stated he would be getting a bid from Simmons Tree Service to trim trees on Webster and Sandusky St. If this could not be done out of the current budget, the Street Department may take care of trimming these trees on their own.

Commissioner Reddy:

- Fred reported that Adam McCoy had started working on Monday for the water and wastewater department.
- A motion was made by Fred, seconded by Jerry to approve the Tax Compliance Certificate and Agreement and approve the Illinois Environmental Protection Agency Loan Application.
