David Biggerstaff asked if the Village had been notified of a final outcome regarding the Illinois Commerce Commission's decision to Aqua's request to raise the water rate for the Village by forty-seven percent. Mayor Schmink stated that the Clerk has reached out to the ICC and Aqua and had received conflicting determinations and until the Board is certain of which answer is correct, the board did not want to comment. Mayor Schmink stated he wanted to make sure the information was correct before informing the residents of Catlin.

Commissioner Schmit:

- Wanda stated that the resurfacing of the tennis court and purchasing of some new equipment for the park is included within the new park budget. There are some grants available for these items and those will be pursued.
- Having the trees trimmed along Webster St and Fleming St also needs to be addressed.
 Mayor Schmink stated that during his walk through of the sidewalk replacement with
 Roland White of Fehr Graham, three trees were identified that will need to come down
 for that project. These three trees are on Village property. A bid from Simmons Tree
 Service will be obtained to be presented to the board.

Commissioner Kirk:

- Kevin stated the street department has patched some potholes but due to weather, they won't hold up very well. When the weather breaks, cold patch will be used to make these better and to fill other potholes.
- A lot of time has been spent by the street department, clearing catch basins and cleaning
 up brush and debris from the Allison St. house that is now owned by the Village. This
 will allow the street department to mow the property this summer, if still owed by the
 Village. Kevin instructed the Village Clerk to call Ameren to have the gas service
 disconnected from the property.

Commissioner Reddy:

- Fred reported that surveying had been done at the wastewater plant by Fehr Graham last Thursday.
- Matt Johnson, from Fehr Graham updated the board regarding the progress on the wastewater plant. A study session will be held prior to the next meeting on April 17th, giving a detailed account of the preliminary design.
- Matt also explained the Illinois Environmental Protection Agencies new guidelines regarding the NPDES permit. This plan, a CMOM plan, will cost an estimated \$5,000 to \$10,000. This has been added to the next years 'Wastewater budget under 'CMOM.' This plan is record keeping and formalizing a goal for the Village to track wastewater, to ensure that it is treated and released properly and that wastewater doesn't appear in places it shouldn't, such as basements. The plan is made, approved and then executed.
- Matt also explained the diesel pump bid that was submitted to the board. Matt stated that after the "first flush" this year, wastewater debris that had settled over the winter was flushed into the wastewater plant and all three pumps broke down. With the plans to rebuild the wastewater plant being twelve to fifteen months in the future, safety measures can be taken to make sure wastewater is removed from the system, preventing the threat of wastewater backing up into homes. The bid for this pump is \$60,000. Mayor Schmink and the Village Clerk are meeting with Chairman Marron on Friday to see if the County's Infrastructure budget would be able to help purchase the pump.
