#### Commissioner Schmit:

- Wanda informed the board that clean up days have been set for June 16<sup>th</sup>, 2018 at the Village maintenance building.
- Vermilion County Land Bank has been contacted in regard to the property at 406 Allison.
  Wanda updated the board that they are trying to reach a resolution that will work in the favor of the Village and the Land Bank.

#### Commissioner Kirk:

- Kevin stated the street department has started using cold patch to repair the streets.
- Clean up has been completed at the property at 406 Allison to allow the street department to maintain the grass this summer.
- The street department is looking into obtaining bids for some asphalt work that needs to be done.
- Kevin also stated that he is meeting with Chad Osterbur from Fehr Graham regarding some repairs that will need to be done on Vermilion St. Kevin stated this was an eighty-thousand pound street and the Village owns it and it must be maintained.
- A bid was received from Simmons Tree Service regarding tree removal and tree trimming that needs to be done on N. Paris, Webster, Fleming, Sandusky, and Center St. A motion

was made by Kevin, seconded by Wanda to approve the removal of the Chinese Elm on N. Paris St at the entrance of the cemetery due to it being an emergency safety hazard. Aye Fred, Kevin, Jerry, Wanda, Mayor Schmink Nay none

- The remaining trees on the bid would be approved once the new fiscal year budget is passed at the next meeting.
- Concerns regarding the sidewalk that was removed for a sewer replacement on Center St. were brought to the board. Tim stated that the sewer bid included replacing that sidewalk and Steve Liggett was replacing it as soon as the weather allowed.

### Commissioner Reddy:

- Fred informed the board that ten more electronic meters have been installed.
- The board discussed on Aqua's increase rate of twenty-five percent. Mayor Schmink stated he did not want to pass on the increase in rate at this time. Mayor Schmink stated he would like to have the Village Clerk create a letter to the residents, thanking them for assistance in contacting the Illinois Commerce Commission and at this time, their rates would not go up by twenty-five percent. Kevin suggested that the board talk to Fehr Graham to see what kind of impact it would have on the Village to absorb the increase.
- A motion was made by Fred, seconded by Kevin to approve the bid from Courtice|Grason for the inspection on the wastewater facility plant.

Chief Tad Beddow informed the board that he requested the Village Clerk reach out to the Village attorney to have an ordinance written up for underage smoking and vaping. Chief Beddow said this is becoming a bigger problem, including a twelve or thirteen-year-old who is vaping at the Catlin Park. It is already against state law for underage smoking, however, Chief Beddow did not want to write a state ticket that would stay on a juvenile record and clog up the state courts. This ordinance will be presented at the next board meeting.

Chief Beddow, Officer Trimmell, and Officer Weston have scheduled times to present the ALICE training to the Salt Fork School Board and there will be drills at all three buildings in early August. The school board and neighboring towns, including Catlin, Fairmount, and Sidell are working on an Intergovernmental Agreement to allow officers from the different municipalities to patrol and mutual aid at the Salt Fork South Campus.

Village Clerk, Shelley McLain informed the board that the Cross Connection Survey/Letters went out in the mail on Monday with the water bills. This is a survey required by the Environmental Protection Agency and must be done every two years. The EPA requires these be filled out and if they are not turned in, the Village is required by law to turn off any property that does not have the survey completed.
