#### Commissioner Kirk:

- A motion was made to approve the street closure on August 18, 2018 on Commercial Street from Short Street to Sandusky Street.

- The trees on Webster Street have been removed in preparation for the sidewalk replacement project. The bids for the sidewalk project were opened on August 3, 2018, with the lowest bid being from Duce Construction for \$157,300.00. This is 5.7% higher than originally estimated and the Village will have to cover that overage. IDOT will now review and accept the bid, then the Village will formally accept the bid. Construction is scheduled to begin in September.
- Jodi's Asphalt will notify the Village tomorrow when they will begin the asphalt work. The village is responsible for cutting and coring of the current asphalt.
- Street painting has begun. Drennan will be working at the post office tomorrow and the Village will be responsible for this invoice. Mayor Schmink asked for Drennan to look into the storm drain at the Village Hall while they are here.

### Commissioner Reddy:

- Tim and his team has put in thirty-five more new meters.
- A motion was made by Fred, seconded by Kevin to hire Spenser Steward for the wastewater department at \$15.00 per hour and with all the full-time benefits for full time employees.
