Bill Ingram gave a brief history on the building of his house on Carrigan Court and how the culde-sac was paid for by Mr. Ingram but then deeded over to the Village. Mr. Ingram stated that the road needed some attention and he was willing to help pay for the asphalt but didn't want to pay for it all. Kevin stated that Carrigan Court is on the schedule to be asphalted but he would have to look at the schedule and get back to him.

Mel Sanford and Anthony Monson asked for follow up from their attendance and questions to the last Village Board meeting. Kevin stated that the board did reach out to the Village Attorney and was advised that within the Covenants of the Westwood Circle Subdivision under 'Enforcement' the board has no authority to enforce the covenants and in the attorney's legal opinion, the residents of Westwood Circle could contact an attorney to have a Home Owners Association (HOA) created.

Marcus Chenoweth requested approval to shut down Commercial St directly in front of the Catlin Legion on September 15^{th} , 2018 for a concert by Logan Kirby from 6-9 PM. A motion was made by Jerry, seconded by Kevin to approve the street closure.

Tom Taylor stated that last year he had a horrible mouse problem due to the condition of the house at 406 Allison. Tom stated he understood that it would take some time for the house to come down with the grants through the Vermilion County Land Bank. Tom said there is currently a very beautiful fox that is staying around 406 Allison and since the fox has been around, he hasn't had a mouse problem. Tom asked that the board leave the fox alone until the house was taken down. Jerry stated that it is against state law to do anything to a fox.

Pursuant to state statute 50 ILCS 145/2; 65 ILCS 5/3.1-50-10, compensation of elected officials must be fixed by ordinance at least 180 days prior to the beginning of the terms of the officials whose compensation is to be fixed. Kevin stated he didn't see any reason to change the compensation. A motion was made by Fred, seconded by Wanda to leave the current elected official compensation the same as stated in Ordinance 523, passed June 14, 1999.
