• Kevin stated that the street department had been cleaning out catch basins and working on the sewer and storm water line at the corner of McKinley and Webster St. This project would be costly but must be done. The cost would be split between general and wastewater. Kevin praised the village employees for working together on this project.

#### Commissioner Reddy:

- Fred stated that eighteen meters had frozen up during the last week with the extreme cold temperatures.
- Kevin stated that the sewer pump at Dollar General has been damaged due to the mowing crew this summer hitting and damaging the lid. The board agreed that Dollar General would be held responsible for the replacement cost of the pump.
