Tom Baird stated that the activators at the Splash Park were not working but he has ordered a new part to put an activator directly on the building. There was discussion on the incident that occurred Friday, May 31st at the Splash Park and ideas to rectify the situation.

Commissioner Cummings:

- Jerry stated we were waiting on the adjuster to look at the roof on the Village Hall building.
- Fees for all building permits, including roofs are still in effect.

Commissioner Schmit:

• Wanda stated that the shades are up at the park and the new playground equipment is in progress of being put up. Kevin suggested we hire someone to have the holes dug for the playground equipment.

Commissioner Kirk:

- Kevin informed the board that IDOT had hired a third party contractor to replace the guardrails on the Catlin-Tilton Rd. but a JULIE locate was only called in for the west side of the street. When the new guardrail was placed on the east side, the contractors hit the forced water main and the sewer line. There were a lot of man-hours used to repair the break and police hours with part of the road being shut down for the repair. All of this should be reimbursable by IDOT or the subcontractor.
- Bids for the Motor Fuel Tax project were opened today. There were two bids, one from Cross Construction for \$112,418.99 and one from Rhodes for \$132,097.70. Originally planned on spending around \$107,251.00. No action will be taken on this until the next meeting.
- Clean up days are this Saturday, June 8th from 8 AM until noon.
