Mayor stated that the insurance adjuster for the roof on the Village Hall has reported that the roof does have hail damage and would be covered by insurance to be replaced. The official paperwork should be received by early next week.

Commissioner Schmit:

- Wanda stated that concrete has been poured for the new playground equipment being installed in the early childhood area.
- The last Welcome to Catlin sign is being painted by Denis Schmit and should be done and re-installed on the south side of town next week.

Commissioner Cummings:

• In Jerry's absence, Kevin stated that the Motor Fuel Tax project bid was opened two weeks ago and needed to be approved this evening. There were two bids received: Open Road Paving for \$132,097.70 and Cross Construction for \$112,418.99. The original

estimate by our engineers had this project at \$107,251.50. A motion was made by Kevin, seconded by Wanda to approve the bid from Cross Construction for \$112,418.99 to have McKinley St., Crockett St., and tar and chip at the Salt Fork North Elementary roads/alleys resurfaced.

- There will be alley work done on the alley north of the grade school. The school is going to kill the grass and weeds and the village will go in and add road pack.
- No sealed bids were received for the mower. A motion was made by Kevin, seconded by Wanda to put the mower back out for sealed bids.
- Carl reported that it would be about two weeks before the concrete would be poured in the new police garage.

Commissioner Kirk:

- Tim stated that the water lines and sewer lines have been installed in the police garage.
- Matt Johnson stated that the wastewater plant engineering has been completed with the exception of a little of mechanical and electric work and that should be done in the next couple of weeks. The Illinois EPA permits have been received. The next step is to place the project out for bid and hold public hearings. The consensus was to have a public hearing on July 16th at 6 PM to inform the village residents about the impact to water and wastewater rates. After the public hearing, the regular board meeting will take place where the board can approve placing the project out for bid. Construction should begin within three to five months. Matt also requested an amendment be added to that agenda to approve the change in the original paperwork for the engineering agreement that list the IEPA as the source of funds to USDA.

Mayor Schmink:

- Mayor Schmink asked if anyone had any public comments.
 - O Phyllis Nighlinger stated that a tree on village property that fell and damaged her rental house on the corner of Vermilion and Webster St. and requested the Village remove the tree. Phyllis stated she had already turned it into her insurance company and received a check for the repairs. Wanda instructed the Village Clerk to check to see if any contact has been made from Phyllis' insurance company to the Village insurance. Carl was instructed to contact Herb Simmons to have the tree removed immediately.
 - O Dave Biggerstaff asked if a large rock on the corner of Center and Sandusky could be moved out of the right of way. Mayor stated the rock was placed there to prevent people from running over and breaking the catch basin in that area but he would have Carl move it back a bit and see if there is a better solution to the catch basin.
- A motion was made by Wanda, seconded by Fred to authorize Shelley McLain, the DATS
 representative for the Villages to apply for \$20,000.00 from the TIP fund for a
 transportation study focusing on the removal of the railroad crossings within the Village
 of Catlin.
