Brenda Adams, from Keep Vermilion County Beautiful addressed the board. Membership rules have changed that would allow a member to have two representatives that would count towards the ten required events to enable them to have voting rights on the board. At the corporate rate, there would be two voting eligible members and the board would help with two events each year. Kevin asked about recycling within Vermilion County. Brenda explained the difficulties the County has at securing a recycling vendor. Kevin stated that this action item would be added to the next agenda when the Mayor would be present.

• Wanda informed the board that all three of the new trees have been planted at the Village Park.

Commissioner Cummings:

• Jerry stated there were problems with the furnace at the maintenance shop over the weekend. A heater that was given to the Village was used by Denis Schmit to get heat up and going at no cost to the Village. Mayor Pro Tem Kirk stated that there were funds in the Capital Improvement budget to have new tube or radiant heat added to the maintenance shop. Jerry said he would look into this and also the Ameren program to see

Mayor Pro Tem Kirk:

- Mayor Pro Tem Kirk informed the board that there was a water main break on Saturday on Kenfield Dr. The Village employees were able to fix it on Saturday and did a great job.
- The closing on the Wastewater Plant rebuild was today at the Village Hall. Schomburg Construction planned on starting immediately. They will get the site ready for construction now and begin the heavy construction in the Spring. This project will be complete in 18-24 months.
- A blower at the wastewater plant has gone out and Mayor Pro Tem Kirk instructed Shelley to contact the insurance company. Village engineers, Fehr Graham, are also working on a solution for the blower.
