Jeff Fauver, President of Catlin Bank addressed the board concerning the additional securities placed on the Villages' funds held at the Catlin Bank. Historically, governmental bonds are used to secure the funds above the FDIC limit of \$250,000.00. Fauver requested that the board allow Catlin Bank to use a letter of credit from the Federal Home Loan Bank. The letter of credit is supported by the state statues. Kevin suggested that Commissioner Reddy and Clerk McLain reach out to the Village attorney to verify that it is allowed within the Village Ordinances.

• Fred informed the board that the wastewater CD was purchased last week.

Commissioner Schmit:

• Wanda stated that the home at 107 E. Harrison St. has been demolished. The demolition contractor did a nice job and leveled the ground and planted grass seed. Tad asked the Mayor to approve a letter to be sent to the City of Danville, asking for the ticket issued for this property to be dismissed. Mayor agreed.

Commissioner Cummings:

No Report

Commissioner Kirk:

- Tim McFadden, Water/Wastewater Supervisor stated that the department was working on learning the new secondary splitter box at the new wastewater plant and reading meters for the month.
- Kevin asked Matt Johnson, Village engineer from Fehr Graham to give the board an update on the progress on the wastewater plant. Matt estimated that thirty to fifty percent of the work has been done. Two problems, the single working blower and the lack of working influent pumps, have both been addressed. The temporary blower has been set up and being paid out of contingency funds. The dri-prime pump that was received from Vermilion County is keeping the Village wastewater system running. The cost to run this pump on a daily basis has also been covered by contingency funds from USDA. There was a value engineering proposal brought to the engineers from Glesco Electric to change the manholes to handholes. The saving would be an estimated \$10,000.00. The new water line that must be ran is original to the plant, over forty years old and due to the testing that would have to be done on the new line, there were concerns about the old line not being able to withstand the pressure of the testing. A proposal to add shut off valves and the new line was an estimated \$12,000.00. These two changes were proposed to the Village as the first change order within this project. A motion was made by Kevin, seconded by Wanda to approve Change Order #1 for a final cost to the Village to be covered by USDA contingency funds of \$1,714.52.

Chief Beddow:

The concrete will have to be repaired and Jerry stated he would have iron post installed on the side of the concrete pad to prevent large trucks to drive over the concrete.
- Fred asked if there was enough room in the new police garage for all of their supplies. Jerry stated there was more than enough room and the street department was even storing the lighting system and generator in the police garage.
