### Commissioner Schmit:

• Wanda stated that signs at the park have been posted to warn those leaving garbage around the basketball courts if their garbage is not picked up, the basketball courts will be closed. The police had talked and warned those using the park three times last week and Vince spoke with some kids the last two days trying to get the word out that the Village does not want to close the basketball courts but will if they are not using the public park responsibly.

### Commissioner Cummings:

- Jerry informed the board that Illinois Department of Transportation (IDOT) has reached out to the Village regarding a road project they are scheduled to do in 2021. The Catlin-Tilton Rd. along with S. Paris St. from about a half mile south of town through almost the railroad crossing will be repaved next year. IDOT owns those sections of the road but the village owns the side parking area on S. Paris. To have that section of the road, along with the entrances to the side streets included in their project will cost the Village around \$84,000.00. Jerry stated that the Motor Fuel Tax (MFT) account will be able to pay for this and it will save money in the long run. Kevin agreed, stating that it would cost an estimated 33% more once you pay for engineering and the discount of being included into a larger project. Jerry stated this would be added to the MFT budget for the next fiscal year.
- Jerry and Kevin commented on how good the streets were looking.

#### Commissioner Kirk:

- Kevin stated he took a tour of the wastewater plant and was very pleased with what he saw and the progress being made. The electrician is making great headway and, Kevin stated he believed they were ahead of schedule. Work on the new water main that was approved at a previous meeting, has begun and includes the valves that will allow the pressure testing to be done without the risk of damaging the previous older water main.
- More water meters have been changed out and Kevin estimates that by the end of the year, around two-thirds of the Village will have the new Orion meters installed.
- Jerry asked about the meter replacement on N. Webster St. Kevin stated that the sidewalk is already sinking and will need to be replaced along with the meter. The Village employees are scheduled to start this project on Thursday morning.
