Commissioner Schmit:

- Wanda asked the board if they have given any thought to the Farmer's Market being allowed to sell wine and have wine tastings. Kevin stated it was public property and the board has approved this before for alcohol sales during street dances. Fred stated the wineries would need to give a copy of their DRAM insurance to the board and the area needed to be fenced off. Kevin, Fred, Jerry, Mayor and Wanda all agreed that there was no problem with having wine sales and tastings at the Farmer's Market and asked Shelley to inform the other co-sponsor of the event.
- Wanda stated she had a conversation with Steve Liggett about getting the family bathroom done this summer, but with Steve's schedule, this would not be possible this year. Wanda had reached out to another plumber in the area, but they were not interested in the job. Steve Liggett did say that he would have the current park bathrooms upgraded to the touchless toilets and sinks and opened prior to May 1.
- Wanda announced that the Illinois Department of Natural Resources have approved the grant application for the Butler Point Park Trail Grant in the amount of \$143,700.00. The final approval from the Federal Highway Authority is still pending and Wanda hopes this is just a formality and approval will be received soon. The project includes tiling, walking path that is ADA compliant, a new paved parking lot and exercise equipment around the path. Kevin stated that the meeting that was held on this project was one of the most attended meetings and the good news is the price of concrete has not greatly increased in the last year.

Commissioner Cummings:

• Jerry stated he met with Chad Osterbur from Fehr Graham this past week to look at the MFT project that would be done this summer. They discussed repairs to Vermilion St. and also looked at Westwood Circle to have the storm drains repaired and possibly put the final coat on the road if funds permit. Chad is getting pricing and will bring that information back to the board.

Commissioner Kirk:

- Kevin stated the progress at the wastewater plant is proceeding with a lot of wiring, lab equipment and computerized equipment. Excavation of dirt and laying of rock for the road is also being completed.
- New remote meters have been installed and the water and wastewater department will be ordering more to make sure this project continues.

Mayor Schmink:

Mayor Schmink stated that after the last meeting, he was tasked with putting together a
committee to look at the former IGA building and the role that the Village should have in
the outcome of that building. Mayor Schmink stated that ten residents came to the
meeting and it was very well received and great ideas were gathered. The committee
plans on meeting again next month.

Chief Beddow:

- Chief Beddow informed the board that a search warrant was executed last week, upon which fifty cats were seized from a house in Catlin and transferred to the Vermilion County Animal Shelter. The board should be aware that our invoice from the animal shelter may be larger in the next few months, but the Village will be writing ordinance violations to the property owners and will seek any cost and damages incurred by the Village through the courts from the owners.
- Chief Beddow wanted to make the board aware of an incident that occurred the previous Friday night at Casey's. This is an ongoing investigation and Chief Beddow thanked the Sherriff's Department for all the work they have done on the case.
- A motion was made by Jerry, seconded by Kevin to approve the hiring of part-time police officer Austin Buckley.
