Tilton Mayor Phillips is working with the area Mayors and Dave Wesner to form a new city court to process our ordinance violations. There are two ideas of how to pay for this system; raise the court fines or bill each municipality dependent on usage. Kevin and Fred both stated that this was a good thing for the Village of Catlin to pursue and it is our way of maintaining quality of life and enforcing our ordinances.

Commissioner Kirk:

- Kevin gave an update on the wastewater treatment plant. There will be workers down at the plant for the next year and there is a year warranty on all parts. If something goes wrong during that year, the year warranty starts over from the date there was a problem. Tim's phone and the new employee phones are being set up for the plant.
- The lift station on Webster St. went out and Tim and Vince had to work on it all day on Monday. A private company was brought in to drain the system and take it to our wastewater plant. The backup pump has been installed and the broken pump has been taken in to be repaired.

- Matt Johnson from Fehr Graham will be at the next meeting to give us an update on the wastewater plant. Mayor asked if Matt would have pricing for a guardrail on the west side of the road leading to the wastewater plant. Kevin stated he would check into that.
- Dane Weaver started working for the Village today and he came in on Monday to observe the work that was done on the lift station.


A motion was made by Kevin, seconded by Fred to adjourn the meeting by vote.
