Commissioner Cummings:

- Jerry stated that they had a full load of patch and were going to be able to get the patching done. He also stated that the repair work on the storm sewer on Sandusky was completed and the street repaired.
- Jerry also stated that the new truck was working well and that they were going to have running boards added to the sides to make it easier for the village employees to climb in and out of the truck.

Commissioner Kirk:

- Kevin stated that all four pumps at the WWTP had went out over the weekend. He said after many calls between the engineer and the company that sells them that the problem was fixed on Sunday. Kevin thanked Tim McFadden for all of his work over the weekend getting this problem resolved.
- Kevin also stated that there was a bid going out to get the guardrail installed on Westwood. He said this was not covered in the original project and additional funds would be needed, but that we could perhaps use MFT funds to cover the cost.
- He also stated that the goal is still to have all of the automatic meters installed by the fall.

Mayor Schmink:

- Mayor Schmink instructed Leslie to make a note to hold executive session at the next meeting to discuss employee salaries.


