#### Commissioner Kirk:

• In Kevin's absence the Mayor addressed Tim McFadden and asked if he had any updates he would like to share with the board. Tim stated that on Sept 9, 2022 there will be a safety evaluation of the Waste Water Treatment Plant and there is no updates yet from our engineer on the electrical issues they are having.

## Mayor Schmink:

- Mayor Schmink shared with the board a bid from Harvey Dye to contract out the installation of Automatic meters for the village at a rate of \$70/meter up to 400 meters for a total of up to \$28 thousand dollars. With a Labor rate per man for additional work not involved in the meter replacement. This will be paid for with the ARPA funds. Per Tim we have 275 meters on hand ready to be installed and we can get more as needed.
- A motion was made by Jamie, seconded by Jerry to accept the bid from Harvey Dye to install the new automatic meters in the village at \$70/meter with a cap at \$28 thousand and \$75 labor rate per man for additional work not included in meter replacement to be paid for with ARPA funds.
