The board concluded that they would need to get more information regarding the ordinance from our attorney. Mayor Schmink will reach out to the village attorney and see if the ordinance would have to be amended or if a waiver would be possible for this situation.

 & Mrs. Hussar at 103 A Kent Dr. to demo old concrete drive and remove and repour new concrete at an estimated value of \$6,500. Patten Earthmoving LLC will be doing the work.

She is awaiting a bid from the previous contractor to have it redone, he will have the asphalt work subcontracted out.

Commissioner Kirk:

- Kevin reported that the glitches at the plant are being resolved. Fehr Graham had potential customers tour the plant last week.
- Kevin noted that the guardrail is only going to have to be approximately 250ft and is scheduled to go in the week of the 10th. After the guardrail they may not need a riprap.
- Jerry brough up that the storm drain on Taylor needs serious attention, the line is exposed and that it will need to be a double wall for the drainage. Estimated cost will be around \$12,000-\$14,000. Jerry will check the budget for storm drainage.

Mayor Schmink:

• Mayor noted that he fielded 3 calls today regarding the train stopped and blocking all 3 tracks in town. He put a call into the Mike Marron's office and spoke with someone who said they would give his information to Herb Smith with Norfolk Southern in hopes they will hear the villages concerns. Tad stated that per the Supreme Court ruling they can no longer fine/ticket the trains for being stopped on the tracks. The Norfolk Southern police is based out of Georgia and our officers do call.

• Tad advised the board that the house where the garage caught fire on Jackson St is set to be demolished soon.
