Public Expressions:

Trevor Martens and Scott Oliver were present and wanted to talk to the village about their upcoming project. They are going to be installing 400 megawatts of energy equipment in Vermilion County just south of Catlin. 200 megawatts of wind and 200 megawatts of solar. This will be in the Fairmount/Indianola area. There is a 1 ½ mile ordinance within village limits and they would need approval to encroach beyond that. The plan is to start soon into 2024 and to be in operation by 2025.

Commissioner Ridge:

- Jamie stated that he gave the quote for the blinds to Township but has not heard from them yet.

Commissioner Schmit:

- Wanda advised that she is meeting with Michael from Fehr Graham tomorrow to get an update and go over plans for Butler Point Park/Camp Swampy. Right now they are working ahead of schedule

Commissioner Cummings:

- No report.

Commissioner Kirk:

- Kevin noted that the guardrail is in approximately 250ft. Ribbe regraded the road, the water is running to the east so will need to put in fiber cloth and rip rap to try to keep road from eroding.
- Sewer plant is still working on glitches.
- Safety report came back, will get signage and noted violations taken care of to code.

- Kevin has the master list showing approximately 200 meters that still need to be changed over, mainly apartments and houses with the meter inside.
- Looking into finishing over grant funds with an equipment purchase and waiting for specs from Vince.

Mayor Schmink:

- Tad advised that the house at 104 Jackson has been removed and they have seeded the area.
- The park lights are now on a sensor to keep the park lit up at night
- Officers are working later hours


A motion was made by Jerry, seconded by Wanda to adjourn the meeting by vote.
