Public Expressions:

Tad introduced Kyle Allen who's buying some property which used to be the old Lomax estate but needs an address for the property. He was referred to 911 to get an address and they sent him to the village. Tad spoke to the 911 director who told Tad that the village would be the one to assign the address. Tad, Kyle and Vince are supposed to meet to discuss the addressing. It's the dead-end part of Allison Street, Tad would like direction from the board on assigning the address, he and Vince are thinking 503 Allison but asked the board what they are thinking. Kyle can't complete the deal without an address for the title company. Tad got a form to fill out and then it would go before the 911 board and that is how the address would be legally established. With cell phones being tracked now it's putting the caller within 20ft of the property line so they need to know where you are for the address you are calling.

Kyle addressed the board that he is buying a portion of 206 Buckingham, that Frank Atwood bought at auction and Kyle is buying 2 lots off of him from that property. A two story garage that he would like to turn into a three bedroom, 2 bathroom house, and the other he is not sure about and wanted to talk to the board about that regarding the zoning. The apartment complexes are on the backside of the road and this would be right next to the area. His main concern is to get an address for the property to give to Catlin bank to complete the sale. The mayor questioned where the new building would be on what side, east or west. Kyle stated they would be at the end of the road on the west side. The existing building is on the north side of Allison. The new buildings would be Allison St. as well. Commissioner Kirk states that there is history with that garage, that we would have to go back into the file and take a look because at one point when it was built the owner wanted have a maintenance building and then he decided he wanted to put people there and at that time the village declined. He would have to go

back and read that, but in order to separate properties he believes, the village can't do it for him that he has to go through the title company and then bring it to the board. Kyle will get the purchase agreement that shows where Frank already had it worked out with his attorney as to the split up of the property. He would like to have our attorney review it and see if he agrees with it and that it agrees with our ordinances. Kevin stated it's not up to us to set the address, Tad states that according to 911 it is, Kevin says no it's not, Kyle advised that he's called many different numbers and they are telling him that the village has to set the address. Kevin says it's up to the post office. Kyle stated that was the first one he called, and they brushed him off. Mayor says we will confirm with our attorney who's job it is to assign the address and put it to bed. Kyle agreed to that. Kevin says if you divide it into two parcels it changes everything and it becomes a subdivision. They need to research it more. Kyle stated he can have two separate addresses for the lots if we need to do that and asked if he could do that later or if it had to be done now. The board advised to do it all at once. Mayor advised the village clerk to get a hold of the attorney and see who needs to assign the number because he's getting the run around. Tad mentioned stated again there is a form from the 911 board that he just added our headline to that's from the 911 board then we would notify the post office from the 911 director who controls the system. Kevin states that actually we just give the location, and they assign the address. Tad says he is just going by what the 911 director said. The garage would be 503 and then would make the other, that Tad and Vince would talk more and meet with Kyle because they would have to extend the road. In order to buy the property, he need an address for the current building. Kevin says too many things come into play and we have to figure out where our road actually goes. Kevin states that if he owns where the road would be that he would have to pay to extend the road to village engineering specs. The board wants to help and work with him to get it done. We will get a hold of the attorney and get back with him.

Zach Amos introduced himself to the board that he is with the outreach team for Liberty Power and just wanted to update the village as to their conversations with the county about tax revenue that would come from the county from the Mural project. Unfortunately, the county hasn't given the breakdown yet but total revenue is just above \$4.5 mil/year, but they don't have the breakdown yet of where it goes as far as the villages surrounding.

Ordinance No. 776 An Ordinance Vacating a Portion of Street Right-of-Way: This is the one by Fred Rinehart's, Kevin states that this is the one we discussed before and that our attorney agrees and put together the ordinance.

• Jerry got a copy of the agreement for the burn pit that Jerry will take to the guys and see if they agree with it.

Commissioner Kirk:

- Kevin noted that they had a water main break on Martin Court today that was 7ft deep but the guys got it done.
- With the cold weather that we got they did have some problems at the sewer plant that the engineers are working on and things are fine now but that it required time by the supervisor while the guys were off to be there. Kevin believes the problems are just glitches in the system that need to be taken care of that need to be solved before the project is paid out. The plant is operating and well but just some issues with pumps and computers with it shutting down and they just have to figure that out.
- Mayor asked if we are still working on the water meters and Kevin stated that the letter
 has to be done and set up and they we are going to set blocks of time that we can get
 Travis and it has to coordinate that a village representative that can be there as well.
 Mayor asked village clerk Allison to reach out to Travis and set up a meeting to discuss.

Mayor Schmink:

Chief of Police

- Tad let the board know that the Safety Act was ruled unconstitutional and can be tied up court for several months. January 1, 2023 kicks in a lot more training for the officers, more online and more classes.
- Tad advised that he has an address issue with Catlin Mini-Warehouses behind the salt bin area, it's never had an address that he can find, and every 6-8 months they are having instances and it's coming down to the new 911 system, Tad had thought years ago he, Tim and Shelley had come up with an address of 301 Seminary Street but can't remember. The newer officers weren't sure how to get there during an incident last week. Tad is asking for the board direction in which address to assign for it. The permit originally was 304 for farmland. He asked the board if they wanted him and Vince to come up with the address for it, he's thinking 302 or 304 but 911 said they need an address for it. Kevin asked what the village maintenance building was, Tad advised that the other house prior to Seminary is 200 block, but then Nathan was 304, it's offset from the intersection. Kevin asked Tad what his suggestion is. Tad said he's thinking more that it should be Allison, the more he's talked to Shelley to maybe do 300 Allison. Kevin asked what the property out in front of it is, Tad advised it's 304 Allison. Jerry states that if it's on the same side of the street behind that property it should probably be 302 Allison, Kevin agreed with that. Tad asked if we needed to wait to hear from the attorney or to just fill out the form on that one. Kevin stated to just do it and let the post office know and Tad advised that he would fill out the form.
