#### Commissioner Rinehart:

• Fred handed out department budgets to the commissioners and noted that it should be around 63% total expenses and that most are close and that he wants everyone to study them and make notes of any that are circled that would be over in line items. Overall still looks good. General and Wastewater needs to watch their budget lines if it keeps on pace those could be over. Mayor asked if any others would be affected by deposits, Clerk Allison advised that police salaries will be reduced with those deposits. Kevin asked Todd why there is \$27,000 in Wastewater equipment expenses. Todd states could be Lab Equipment he needed to order and maintenance items. Kevin noted that some of these items could possibly be reimbursed by the grant money that is left over. Need to get with Matt to go over those expenses to see what could be reimbursed. Mayor noted we would get Todd a copy of the budget so that he can start noting what lines the items should be billed to. Kevin noted that the clerk isn't going to know where to put those items unless when they are ordering they make note of where to put it.

#### Commissioner Schmit:

- Wanda noted that she got a response back from the IDNR coordinator that the approval request has been sent on and we are just waiting for a response.
- Wanda called and left a message with the chair of the Vermilion County Board to see if their ARPA funds has been distributed yet and has not received a response. Mayor will call to follow up.

#### Commissioner Kirk:

• Kevin noted since the last meeting the guys finished up the water main repair on Mapleleaf. They did get all the Christmas decorations put out. They are ready for winter they had a good amount of sand and salt mix. Plows have been installed and then taken back off but they have been greased and maintained and are ready to go. Had a water main repair on Crestwood, it was a nasty one and worked until around 6pm. Alley repairs on Larkspur, took care of potholes. Filled potholes in the alley of the gradeschool.

### Commissioner Ridge:

• Jamie is out. Mayor asked Todd if he wanted to add anything. Todd stated once he got the budget he could go through and show why he ordered what he ordered. The mayor noted that it's purpose isn't to justify why he ordered items just making sure they get allocated to the appropriate category. Todd noted probably 99% is going to be for wastewater that he orders very little for water.

## Mayor Bargo:

Mayor noted that they are needing to spend the rest of the remaining ARPA funds but before getting to that in the previous meeting we agreed to spend \$16,000 on a generator but since then, that vendor backed out and no longer will do that. GLESCO also quoted but at a much higher cost. Tad said Vince had another contractor quote it and it should be around the same amount that we previously approved, but we are waiting on the quote but won't have that until tomorrow. Since we don't have the quote and since we need to vote tonight, we will have to table the generator since we can't approve it since we don't have the price. Other items for the funds are for Tayor we have 2 bids from Owens and total not to exceed \$36,000. They will install 2 new manholes. Mayor asked if there were any other suggestions on how to spend the ARPA funds. Todd stated we got the two quotes for the skid steer as previously talked about and one for the Chlorine basin as the other was a no quote. The chlorine basin was around \$35K which was pretty high. The skid steer quote was around \$67,000. Kevin noted that he believes the equipment we have can accommodate the sewer plant needs. Mayor said there seems to be a difference in what Todd is stated vs what Kevin is and asked Kevin to elaborate. Kevin stated that the plant just purchased \$100,000 piece of machinery to use down there. That was to utilize down at the sewer plant. The front loader. Kevin asked if there was an issue with Todd using the front loader for the reason it was purchased and Todd said that he can use it, that it's just big and tight with some of the corners. Kevin stated we still have the skid steer that it could be cleaned up and used. Todd agreed that we would have to put money into it, getting new tires etc. Mayor suggested to get pricing on parts for the skid steer to get it updated vs buying new. The reason they suggested a cover for the chlorine basin is to prevent the sun from hitting it and causing algae. Kevin asked why that wasn't included in the plans for plant to begin with and could have been part of the grant

funds. Could we use some of the retained grant funds to pay for part of that? Kevin states we can look into that. Tad brought up the streets department got a quote for \$12,000 for a sweeper to attach to our current front loader. Mayor suggested using remaining funds to update the HVAC units at town hall. Kevin said he would be all for that. He thinks the brush could be done later out of next years budget.

• A motion was made by Kevin to award Owens Contracting their bid proposals to not exceed \$36,500 total to reclaim, set manholes on Taylor Drive.

Wanda thinks that would be taking up too much space. Mayor wants to review the proposal more and talk with the Girl Scouts before voting.
