The Council of the Village of Catlin met in the Village Boardroom in regular session at 7:00 PM with Mayor Justin Bargo presiding. He called the meeting to order and the roll was called.

COMMISSIONER RINEHART

A motion was made by Rinehart, seconded by Schmit to approve building permits for a pool at 408 N Sandusky, a fence at 105 Meadowlane, and replacement siding and refurbished porch at 122 Kent.

Dave Biggerstaff has proposed some changes to the solicitation ordinance. The board all agreed that the changes were fine. He and Chief Beddow will meet with the attorney and bring the final ordinance back to the board for approval at a future meeting.

COMMISIONER SCHMIT

A motion was made by Schmit, seconded by Rinehart, to withdraw from the Illinois Department of Natural Resources grant process.

Schmit explained that the village did not have the funds to go forward with the project, which has doubled in cost due to COVID since the grant was received. There is \$40,000 in the budget that was allocated for the village share of expenses. They will have to pay back the \$11,000 that has been spent for engineering costs.

COMMISSIONER WILSON

Commissioner Wilson met with Ribbe Trucking about bidding on the following additional streets: Mill Street and the alley, Mae Drive, Clay Street, Lookout Street and Burgess Street. That is an additional 2838 feet of roadway which should be about \$50,000. Burgess Street will be torn up by the elevator demolition, so Biggerstaff should talk to the contractor about them paying for fixing the street.

A motion was made by Wilson, and seconded by Rinehart, to accept the bid from YR Tireman for \$1291.96 for new tires for the skid steer.
