• Kevin noted that the Taylor Drive project is completed. There was additional work that had to be done due to a water main break. A hydrant was put in at the dead end. Fred asked about a guardrail. Kevin advised he can look into but it is sloped and a guardrail was not put in.

- Kevin noted that the lawnmowers have been serviced and the 1st mowing of the season has been completed.
- Kevin stated that the meters were read and they are trying to schedule the plumber to dewinterize the park bathrooms after the locks are repaired as someone broke off a key in the lock.
- Trees were trimmed on viewpoint.
- New street sweeper was delivered and the guys were testing it out.
- Kevin has set a meeting for next week with Chad Osterbur of Fehr Graham to go over streets projects for MFT. They will be working on the sidewalks as well as doors to the community room. Some areas need asphalt replaced and a contractor will work on those repairs. Streets department has prepared a list. Mayor would like to be present as he has a list as well.
- Kevin noted that for the Wastewater plant that the sludge has been delivered to the farmer.
- Training for the employees at the plant will be in April with Fehr Graham.
- There is maintenance of equipment and motors that they will need to see which ones need serviced.
- Kevin noted that we are still waiting on the online booklet for the CMOM implementation.
- Kevin said that going forward when we have water turn on's that someone must be present to have it turned back on.
- Mayor noted that we need to have some sort of task force/group to help identify the meters that still need to be replaced.

- Mayor presented the IGA for Mike Stiles with the township. Will vote at the next meeting.
- Mayor asked Kevin to have Vince oversee repairs that need to be done with the community room.
- HVAC's have been replaced/installed

- Tad advised they picked up the new car last week. North Campus will use the new car.
- Tad presented a quote for body cameras in the amount of \$5,370.00, he says with the technology always changing he feels it's better to go this route instead of \$30+K. The board agreed. The quote is good until the end of April. He will look to put them in service around Thanksgiving to Christmas so they'll be good to go by the end of the year.

Dave Biggerstaff Report

• Dave proposed possibly updating the ordinance to specifically state not to pour concrete around the meters. He also brought up new construction and residents doing projects without having permits. Kevin stated that there are stop orders in the ordinance. Dave stated that the ordinance should be updated and fines and it should be updated in the

- ordinance to clarify. Dave suggested we visit our permit fees and possibly increase fees for new construction and others and add a category for solar panels, Dave also suggested that the village accept credit cards for permits, the mayor advised that we would need to look into that further with the fees vs what we charge.
- Dave reported on the properties that he's been working with regarding ordinance violations. Dave noted that 504 S. Paris that the Municipal League Insurance adjuster will be scheduled to come out to asses damages. He also noted that the Grain Elevator is making progress and he will be meeting with someone soon.
- Dave presented a couple ordinances that will need to be reviewed. He advised that the process had started on previous mayors but didn't get executed and filed with the county so it's never been updated and needs finished. Will present for approval at the next meeting.
