I was informed this evening that we do have a possible water main leak on Webster Court unfortunately that is the area that we just had asphalted and the vibration from the machinery possibly caused this we will have to go ack in and figure out what is wrong. Down at the sewer plant we are currently working on odor control it will be handled do not know how long it will take it is coming out of the settling bins that we have there every time we stir them it rains. We are just catching up from the winter. We do have the property at Lookout/Davis the owner wants to asphalt the area and it would be in our best interest to asphalt the approach and the owner will do the rest. The owner went and got 2 estimates one is for \$19,700 and the 2<sup>nd</sup> bid for \$10,295 our portion would be 1150 Sq ft at the cost of \$4312.00
