The current line locater has a range of only 15-20 yards before it loses signal. We had a salesman from Schulte Supply bring out a test wand and it located over 2 and ½ blocks and was still locating. For this new wand the total quote was for \$5500.00

A Motion was made by Ross Wilson and seconded by Kevin Kirk to purchase a new line locator and transmitter from Schulte Supply Inc for \$5500.00 not including taxes and the cost be split between Water and Wastewater.

Have another quote for a heavy-duty gas trash pump and wheel kit. This is for when a water main, sewer line breaks or storm water needs to be pumped out for \$2145.00.

responsible. Also need to investigate making a new form so that we have the landlord information and tenants' information at the time of application for water service.

A motion was made by Kevin Kirk and seconded by Wanda Schmit to make a new form to include and be signed by the owner/landlord of the property as well as the tenant and submit it to the village before the water can be turned on.

We also need to make sure we have a payment plan in place if the water has been or is going to be shut off that both the owner of property and/ or if there is a tenant both sign the payment plan and that they will have up to 1 year to pay in full.

Mayor: Also, Lorrine Kinney has been notified of the termination of the agreement for the use of his wastewater license, effective September 30,2024

I do have an example ordinance for the 1% grocery tax that will have to be slightly amended for the village Catlin that I pulled from the IRS website, for those of you who that may not know the state is ending the 1% tax advising the individual government/municipalities should implement their own. I would like a motion to implement the 1% grocery tax at the time the state ends theirs.
