October 15, 2024

The Council of the Village of Catlin met in the Village Board room in regular session at 7:00pm with Mayor Justin Bargo presiding. Mayor Bargo called the meeting to order at 7:01pm and instructed Village Clerk Autumn Lange to call roll.

Roll Call:

A motion was made by Wanda Schmit and Seconded by Ross Wilson to approve the agenda for the meeting, October 15, 2024.

A motion was made by Wanda Schmit and Seconded by Ross Wilson to approve the minutes from the regular board meeting held on October 1, 2024.

A motion was made by Ross Wilson and Seconded by Wanda Schmit to approve the bills presented. Aye: Wilson, Kirk, Schmit and Bargo

Public Expression:

- Wendy Navel and Brock Read attended the meeting on behalf of Metro/Conxxus who is
 installing the Fiber Optic lines currently through the Village. There have been 2 supply lines
 busted during the installation so far so some of the streets employees also attended the
 meeting so everyone can be on the same page moving forward regarding their work and to
 prevent damage moving forward.
- Kim Powell with Scanics, LLC presented information regarding their cloud-based storage program known as "SILO". Their services would include digitizing any documents, shredding, printing, etc. Kim spoke with the Property Manager, Dave Biggerstaff, to come up with a more personalized presentation for the board that included how we could potentially digitize all the property files to make them more easily accessible for employees. The Village will continue to review their services and determine later whether they want to pursue this opportunity.
- Jason Biava from Atlas Total Homes attended the meeting to discuss more about the solar panels before the board made their final decision on installation. A solar panel breakdown sheet was assessed by the Board Members as Jason discussed that the rebates for the panels are guaranteed so the final price after those is \$7,472.31 and there are multiple

incentives/grant opportunities after installation. For the panels, there is a 10-year leak warranty, 25-year manufacture warranty, and 30-year Caulk warranty. Jason also expressed that there is an opportunity to install a TV within the Village Hall so community members can see the data from the panels that would include how much money the village is saving after installation.

Commissioner Schmit: Commissioner of Public Health and Safety

Commissioner Schmit discussed Halloween and determining the Trick or Treat hours for the Village. Motion made by Kevin Kirk and Seconded by Wanda Schmit to set the Trick or Treat hours for the Village to be 5:00pm – 8:00pm on October 31, 2024.

Commissioner Schmit also discussed the issue with loose dogs running around the village. After looking through the village ordinances and discussing with the Chief of Police, we encourage the community members to call the non-emergency line (217-442-0153) to report a loose dog so that the Police can address the issue immediately and issue a citation. If a dog is seized by animal control, it is the owner's responsibility for all fines and fees.

Commissioner Wilson: Commissioner of Streets and Public Improvement

Commissioner Wilson is going to reach out to the President of Metro/Conxxus to discuss the work in town and determine if we can stop the work as of October 31, 2024, and resume the work later in the spring due to lack of resources and manpower as we near the winter months. He hopes to have an update for the board at the next meeting.

Commissioner Kirk revisited the discussion topic of the communication between Metro/Conxxus and the village employees. Each morning, someone from Metro/Conxxus should do a daily report with the village employees to ensure that everyone clearly understands the expectations for the day.

Mayor Bargo:

After more discussion with Jason Biava from Atlas Total Homes, Mayor Bargo believes it would be a great idea to proceed with the solar panels to cut down energy costs and provide more room within the budget for various other village opportunities. Motion to approve solar panel installation for the Village Hall, Wastewater Treatment Plant, Police Garage/Streets Garage and Park for an initial price of \$96,579.00 by Ross Wilson and Seconded by Kevin Kirk.

Mayor Bargo presented the 1% Grocery Tax Ordinance No. 788 to be reviewed. Motion to approve Ordinance No. 788 that goes into effect January 1, 2026, by Kevin Kirk and Seconded by Wanda Schmit.

The Board reviewed the Budget Carryover presented by Mayor Bargo that broke down some of the invoices that were supposed to be paid during the previous fiscal year but ultimately paid during this fiscal year.
